# KIDS UP WARRANTY

#### LIFETIME LIMITED WARRANTY

For the lifetime of your product from the date of purchase, Pride will repair or replace at our option to the original purchaser, free of charge, any of the following parts found upon examination by an authorized representative of Pride to be defective in material and/or workmanship:

### Structural frame components, including:

■ Side Frames

Cross Frames

## ONE-YEAR LIMITED WARRANTY (TWO-YEAR WARRANTY IN CANADA)

Pride warrants this product, so far as the same is of its own manufacture, to be free of defects in material and workmanship, when used by the original purchaser under normal conditions, for one (1) year [two (2) years in Canada] after purchase. Our sole liability is to repair or replace covered parts. This is the exclusive remedy for consequential damages.

#### **WARRANTY EXCLUSIONS**

The warranties herein specified shall not apply if the failure of any component of this product to satisfy such warranty is due to accident, neglect, misuse, improper transportation arranged by the purchaser or its agent, or causes other than ordinary use including operation contrary to Pride's operating instructions or if any person other than Pride's authorized personnel, a Quantum Rehab Provider, or authorized agent shall modify, adjust, or repair such product or perform any related service on it.

This warranty does not extend to those items which may require replacement due to normal wear and tear:
